MESSAGE FROM CHIEF JACKSON

I am pleased to provide this 2025 annual report documenting the work of the Jamestown Police Department. This year saw a 2.35% decrease in crime. In late 2025, the Jamestown Police Department was the recipient of the NYS Statewide Targeted Reductions in Intimate Partner Violence (STRIVE) grant funding which aims to improve the response to intimate partner abuse and domestic violence. This funding, in the amount of \$309,815, will be used by the Jamestown Police Department's Domestic Violence Unit (Project Crossroads) to enhance our services to victims, as well as hold offenders of domestic violence accountable.

Recruitment remains a top priority within the agency. The department will be implementing new initiatives in 2026 to attract more officers. The department has begun forming a recruitment team of volunteer officers motivated to bring career law enforcement officers to the Jamestown Police Department. Also, in 2026 the Zone 13 training academy will also begin a Phase 1 and Phase 2 curriculum, which will lessen the financial burden placed on recruits as well as allow local agencies to sponsor and hire recruits sooner than previously.



This year saw the retirement of K9 Officer Erik Kraft as well as Lieutenant Greg Wozneak. Lieutenant Matt Bentley left the department to take the position of Chief of Police in Lakewood, NY. Lieutenant Wozneak also accepted the position of Chief of Police in Westfield, NY after his retirement. This year the agency welcomed five new officers to the ranks. Lucian Talbett, Nick Jones, Emma Hollenbeck, Chase Stevenson, and Jonathan Gomez-Martinez all began their law enforcement careers at the Jamestown Police Department. Donna Giordan and Cathleen Reich were hired as civilian staff in 2025.

The Jamestown Police Department indoor range is nearing completion after a much needed upgrade. Through the use of ARPA funds the department has a new, modern facility for training that can be used for many years to come.

The department continues to work with the Department of Development (DOD) to hold offenders accountable for those that take advantage of vacant properties throughout the City. Trespassing, larcenies, criminal mischief, and other offenses are often committed in areas of blight.

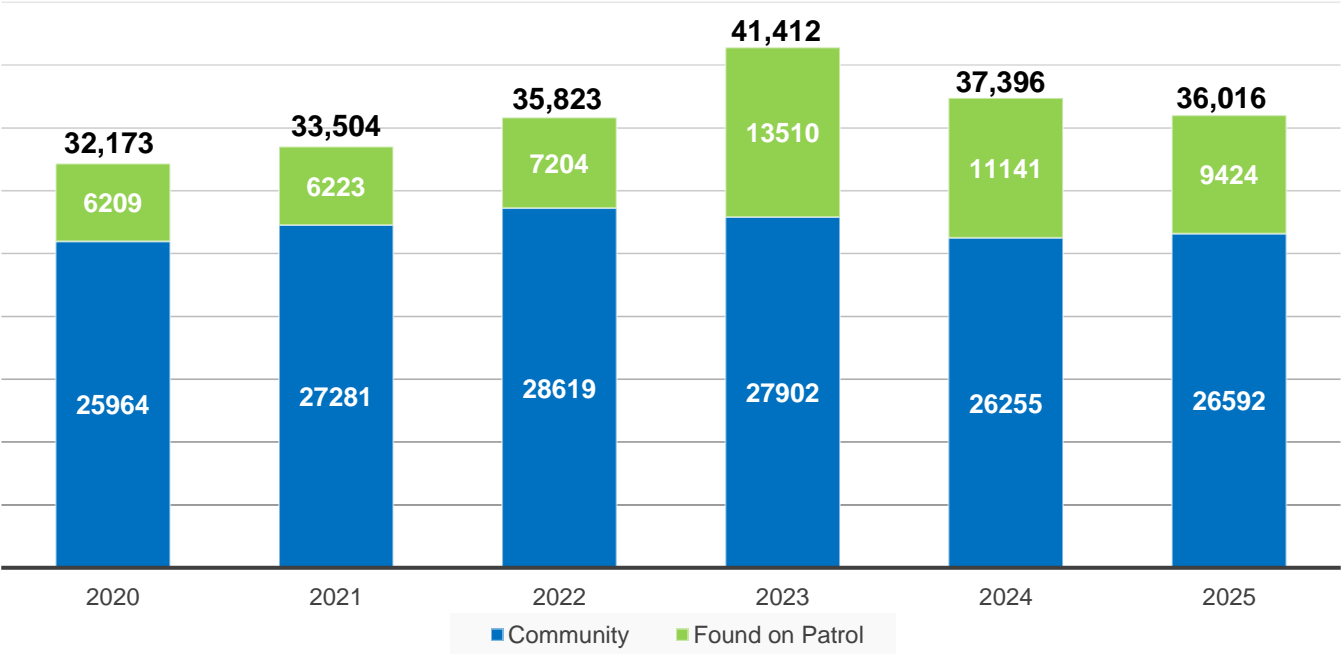

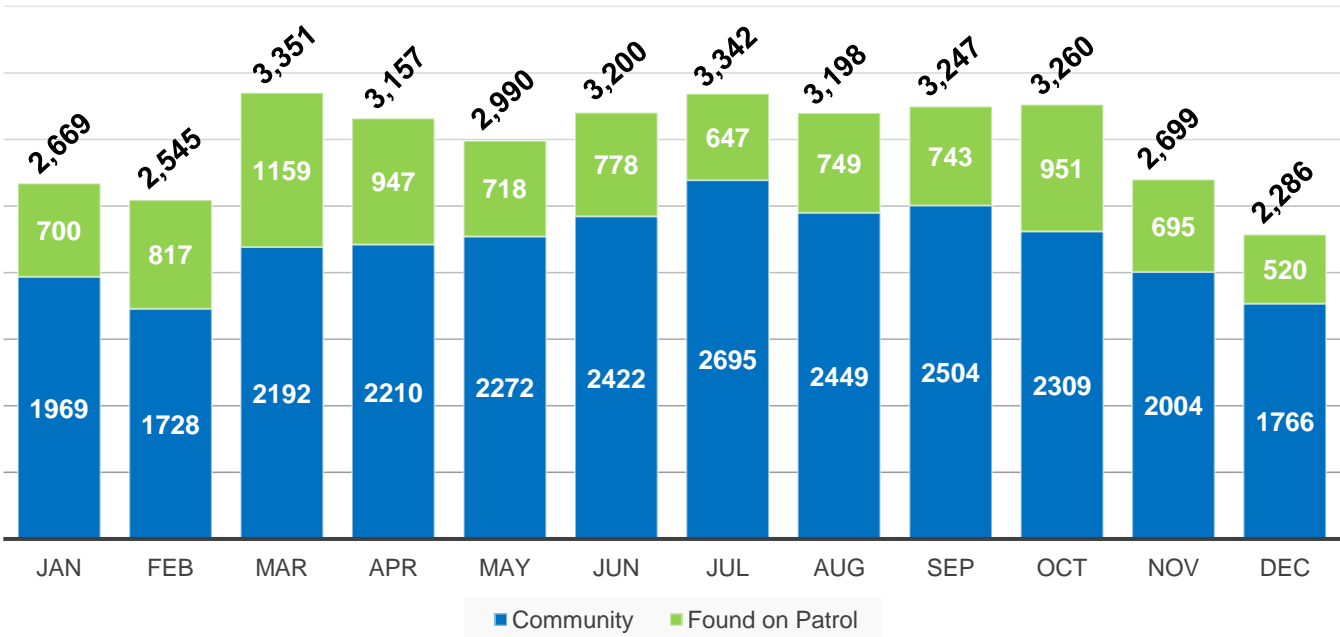

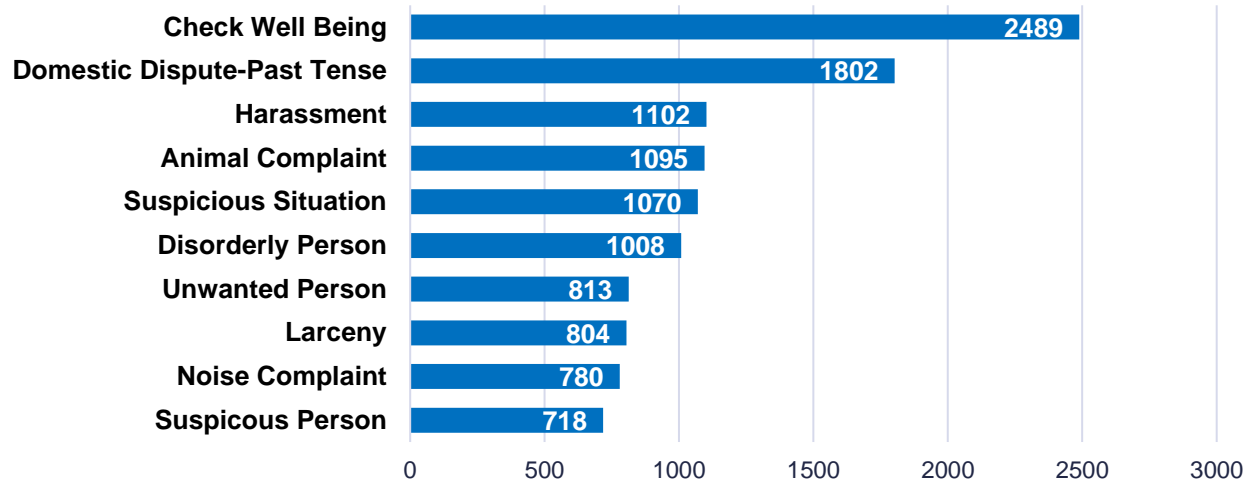
COMPARISON OF INCIDENTS PER YEAR



INCIDENTS BY MONTH IN 2025



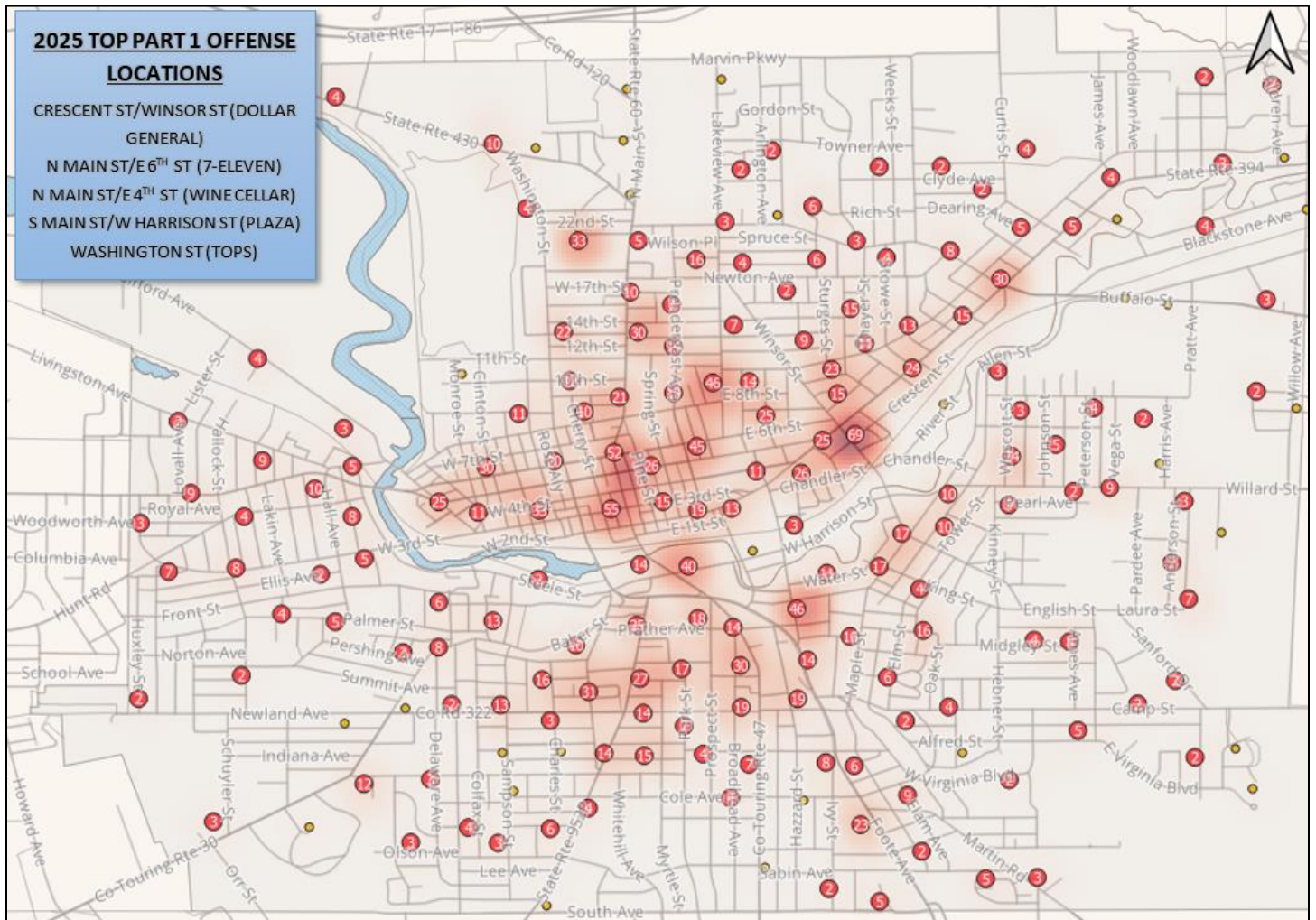

2025 Reported Part 1 Offenses in Jamestown, NY Density Map



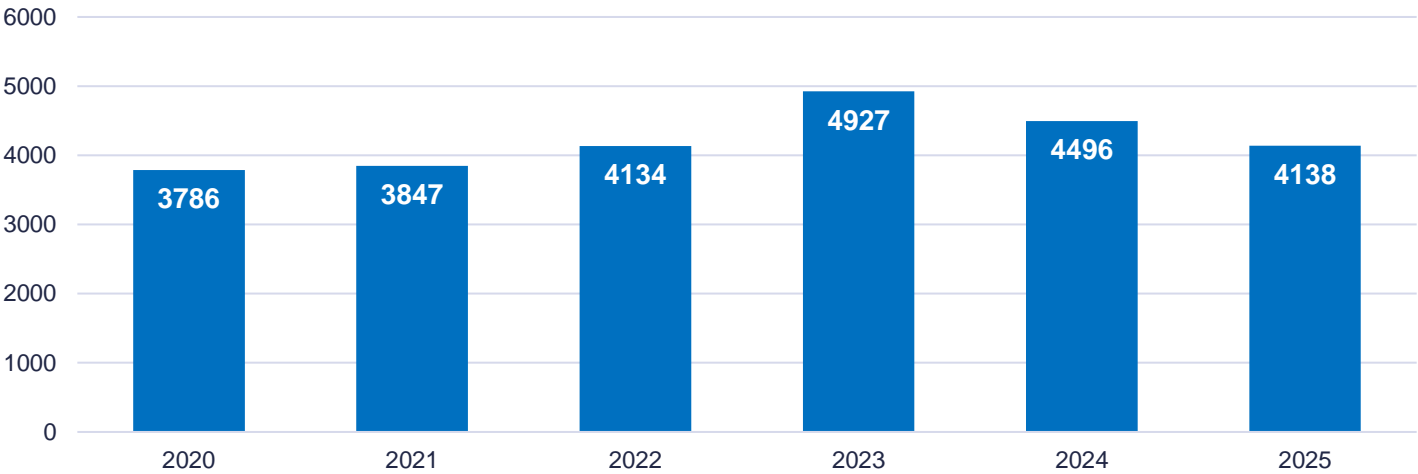

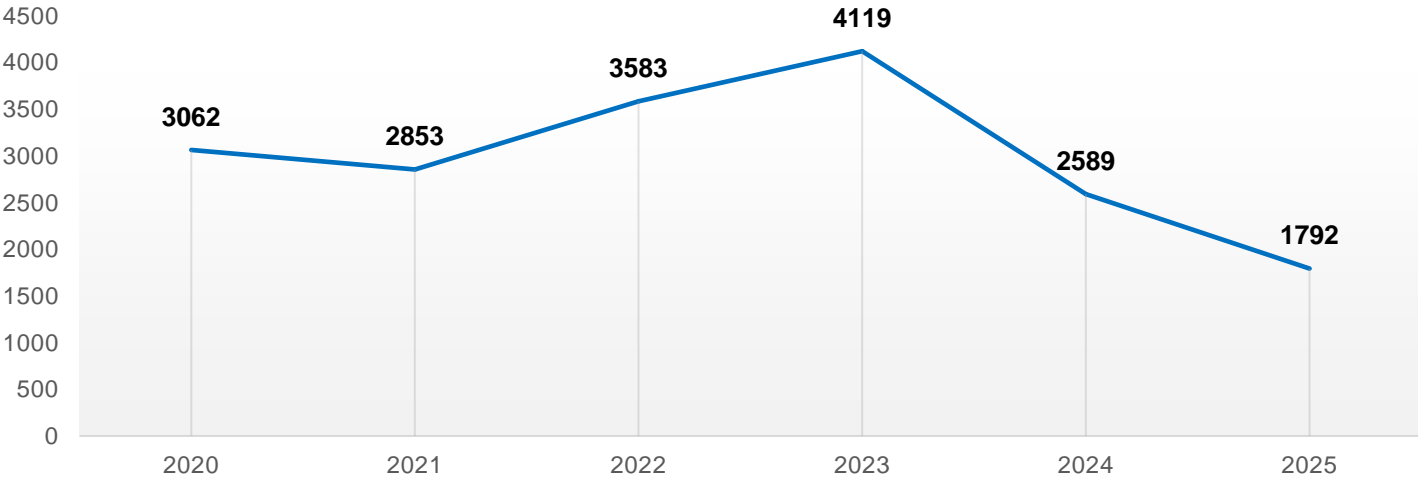
Incident Based Reporting Part I and 2 Offenses/Arrests in 2025

COMPARISON OF IBR OFFENSES PER YEAR



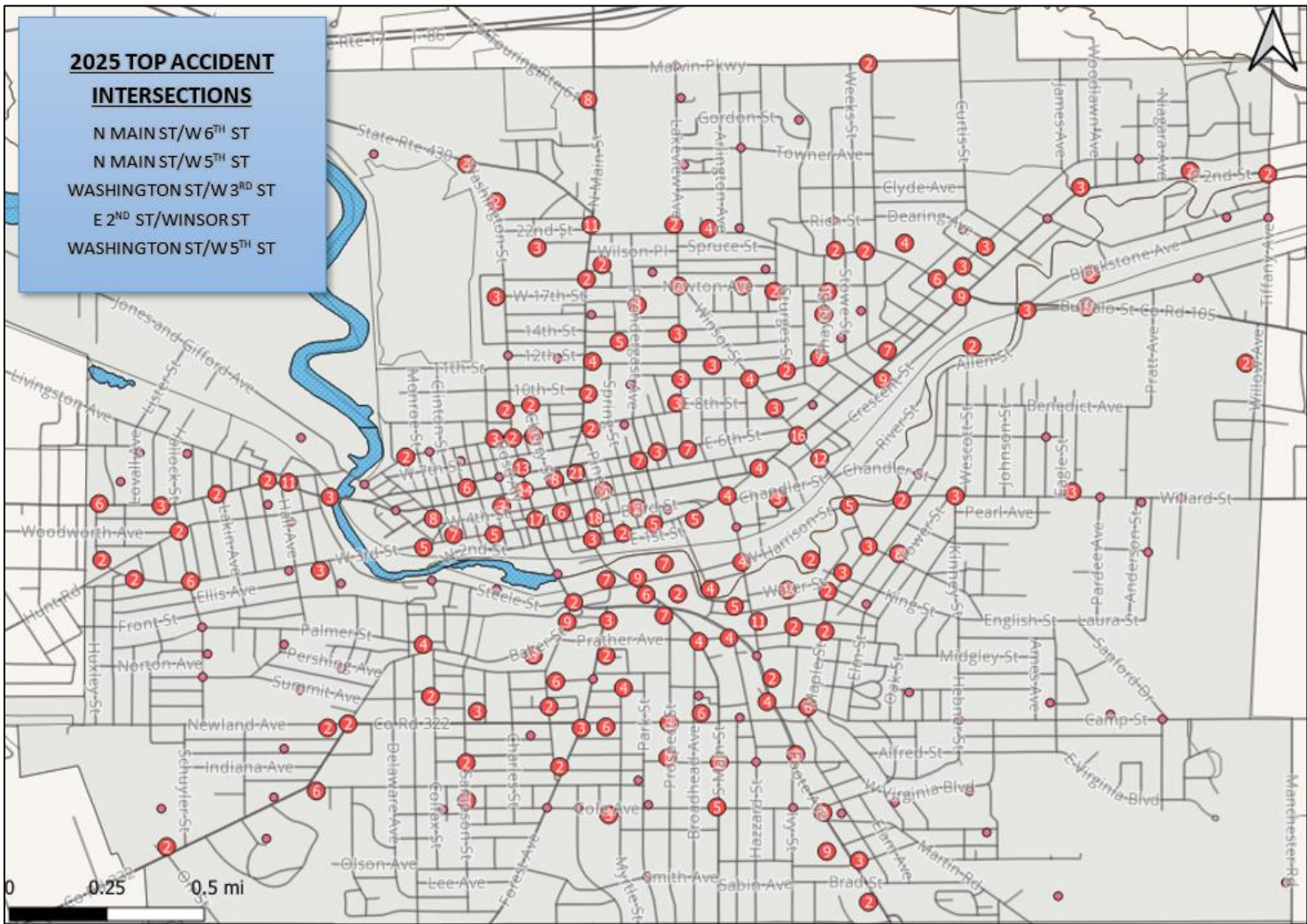

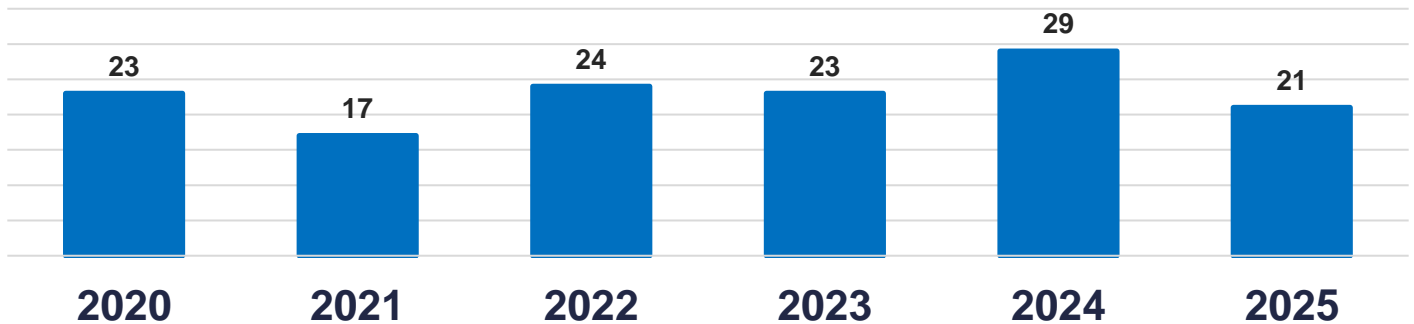

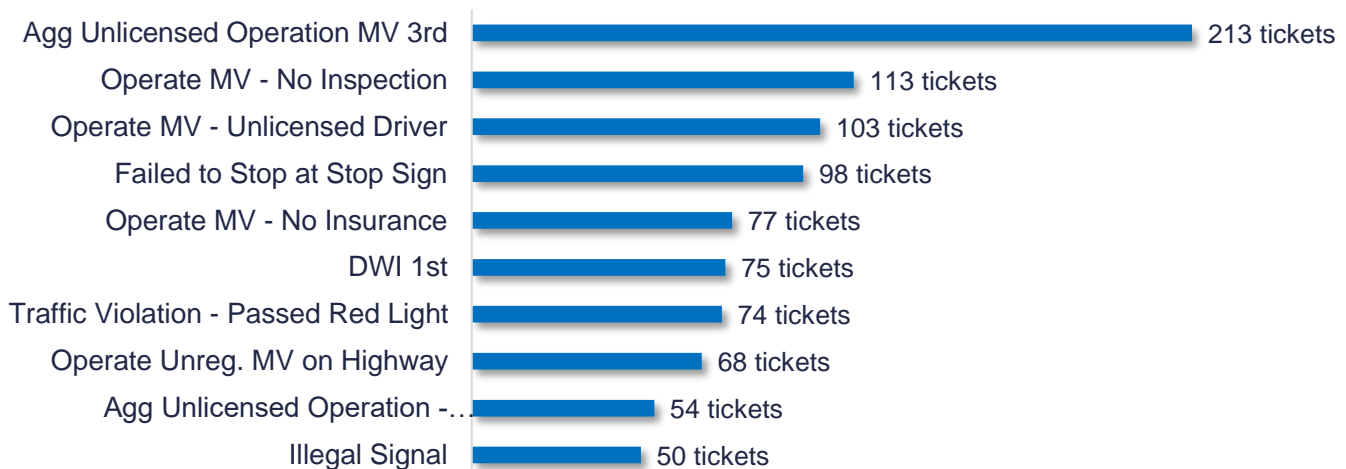

OPERATIONS DIVISION

The Jamestown Police Department is separated into two sections, Operations and Administration and both sections are overseen by the Deputy Chief. The Operations Division is responsible for providing direct police services to the public. The members of the Operations Division are committed to our citizens through the:

- protection of life and property,
- protection of the constitutional guarantees of all people,
- reduction of opportunities for the commission of crime,
- resolution of conflict,
- identification of criminal offenders and criminal activity,
- apprehension of offenders, and
- coordination of the efforts of the Jamestown Police Department with other police agencies.

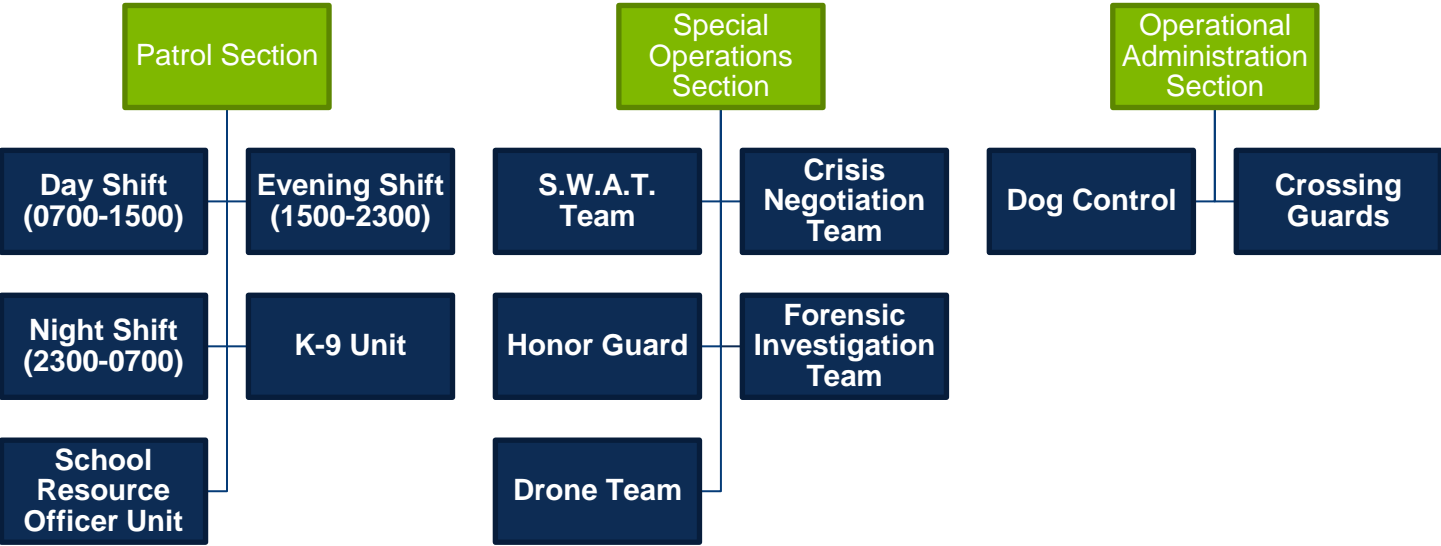


Deputy Chief Scott Forster

The Jamestown Police Department is committed to working with the citizens of Jamestown to create a relationship between the community and its police department to not only reach, but to set new goals to achieve to reach a common objective.

There are 56 sworn police officers, a dog control officer, and five crossing guards assigned to the Operations Division. These officers represent the front line of the department and are in most circumstances have the initial contact with the community. Members of the operations division continue to stay vigilant and proactive in the patrol duties on a daily basis. They also offer themselves to be more accessible to the community and have a direct relationship with community members to build trust, which assists in the reporting and investigative efforts of these officers.

The City of Jamestown is the largest municipality in the county and continues to experience over half of the violent crime that is committed countywide. The Operations Division encompasses the Patrol Section, the Special Operations Section, and the Operational Administration Section. Deputy Chief Forster is also responsible for coordinating the agency’s commitment to New York State Division of Criminal Justice Service’s grant funded programs.



Patrol Section

The Patrol Section consists of three platoons of uniformed officers who staff three shifts each day. In each platoon, a lieutenant serves as the platoon commander. The lieutenant has overall responsibility for the administrative and daily supervision of platoon activities. Each platoon is divided into three squads with three or four officers assigned to each. In addition, two sergeants are assigned to every platoon as supervisors.

The Patrol Section is responsible for proactive patrols, responding to calls for service, initial and follow up investigations, traffic and parking enforcement, community relations, neighborhood awareness and reaction to neighborhood problems.

Additionally, the Patrol Section provides a communications officer for each shift. Usually a sergeant, the communications officer is responsible for operating the Command Center at the Jamestown Police Department. This position is responsible for monitoring and assisting the Dispatch Center, operating E-Justice and computer systems, and assisting the public at the station.

The Patrol Section also operates the City Jail. Patrol officers and patrol command staff are responsible for the control, incarceration, safekeeping, and humane treatment of prisoners in custody, in addition to booking and related processing of prisoners in custody, assisting the Court Security Unit with persons they arrest, and coordinating transportation of prisoners to the County Jail.

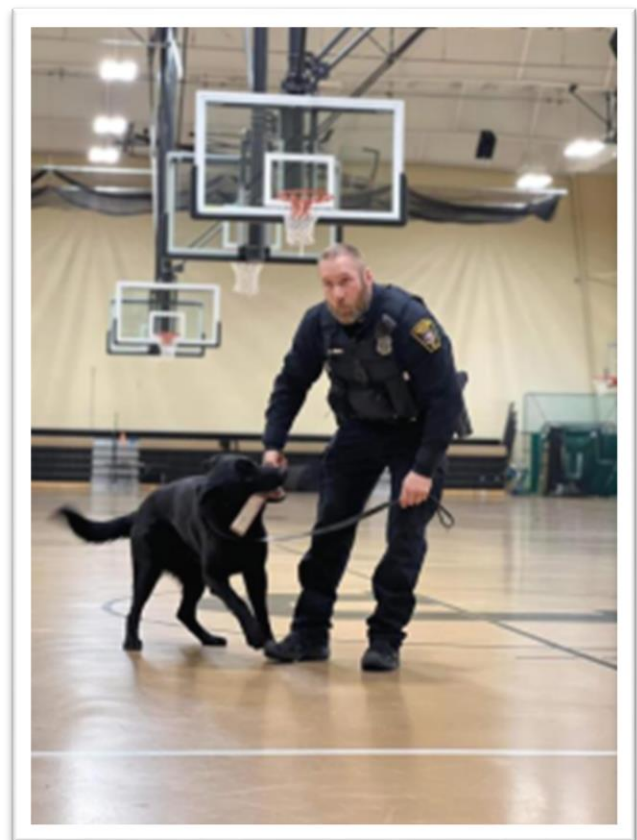

Special Operations Section

The Jamestown Police Department maintains four special teams that are staffed by officers as an “additional duty”.

Special Weapons and Tactics Team (S.W.A.T.)

The Jamestown Police Department Special Weapons and Tactics Team (S.W.A.T.) is a volunteer group of specially trained personnel assigned specialized weapons, supplemental safety equipment and other specialized devices to overcome prolonged life-threatening situations, such as: barricaded subject situations, hostage situations, anti-sniper incidents, drug interdictions, high-risk warrant service, and security for visiting dignitaries. The team was commanded by Lt. Adam McKinley. In 2025, the team completed 19 missions and 12 separate training sessions totaling 96 hours. One mission was a call-out, to assist in French Creek, for an officer-involved shooting where a Sheriff’s Deputy was injured.

Crisis Negotiations Team (CNT)

The Jamestown Police Department Crisis Negotiations Team (CNT) is a nine-member team that is specially trained and equipped in the management of crises, such as: hostage incidents, barricaded subjects, or suicidal subjects. The purpose of the team is to bring crises to a peaceful conclusion using negotiations – thereby minimizing the potential for injury to citizens and officers. Negotiators are state certified, have completed the F.B.I. Crisis Negotiations School, and train on a regular basis jointly with Jamestown Police Department S.W.A.T., New York State Police, and numerous other western New York law enforcement agencies.

The Jamestown Police Department Crisis Resolution Team is under the command of Sgt. Kyle Mann and includes, Sgt. Timothy Mason, Det. Craig Damon, Det. Matthew Rhinehart, PO Jose Moya, PO Kaitlyn Guynup, and PO Jakki Ahlbin. Former member, Lt. Matthew Bentley left the team after becoming the Chief of the Lakewood Police Department. Sgt. Steven Bentley and PO Michael Yezzi are new additions to the CNT team.

Operational Administration Section

GRANTS

POLICE TRAFFIC SERVICES GRANT:

The Police Traffic Services Grant is awarded annually and provides funding to support seatbelt and occupant restraint enforcement during specified statewide “enforcement waves” and expanded enforcement efforts directed by our department. Pro-active patrols also target aggressive driving, speeding, distracted drivers, cellular phone, and other dangerous driving behaviors. In 2025, our agency was awarded \$8,680.

OPERATION SAFE STOP:

Operation Safe Stop is a statewide enforcement initiative that is not funded by any grant. Our agency and the Jamestown Public School District participate in this program annually in the spring of each year. The goal of the initiative is to ensure motorists are not passing stopped school busses and cite motorists who violate this law.

GUN INVOLVED VIOLENCE ELIMINATION INITIATIVE:

In 2014, New York launched a new effort called the GIVE (Gun Involved Violence Elimination) Initiative, an innovative program designed to build on the success of Operation IMPACT while focusing exclusively on shootings, homicides, and violent crime. For the City of Jamestown, GIVE focuses on all forms of violent crime. In 2025, Chautauqua County was awarded a total of \$738,212, with \$309,980 designated for the Jamestown Police Department. The grant has allowed for the expansion of funding to hire a Crime Analyst and a full-time Anti-Violence Coordinator. The Crime Analyst works to collect and evaluate crime data, identify trends and hot spots, and assist with investigations. The Anti-Violence coordinator oversees the management of the grant and collaborates with county partners to implement the GIVE strategies. These efforts work to reduce incidents of shootings, aggravated assaults, and other violent crimes by promoting integrated, evidence-based approaches that include four core elements:

- People – GIVE jurisdictions will target the key individuals and groups, also known as the “top offenders,” responsible for most gun violence.
- Places – GIVE jurisdictions will target the key locations, or “hot spots,” where most violence is occurring.
- Alignment – GIVE jurisdictions will align their efforts and coordinate strategies with other local violence-prevention efforts.
- Engagement – GIVE jurisdictions will engage key stakeholders and the community at large, communicating and coordinating with them to ensure wide-ranging support.

The Chautauqua County GIVE partnership increases the number of joint patrols conducted with agencies such as the Chautauqua County Sheriff’s Office, NY State Parole,

Chautauqua County Probation, and the City of Jamestown Department of Development (D.O.D). Officers from these agencies collaborate with the Jamestown Police Department officers to patrol targeted locations, conduct inspectional visits of parolees and probationers, and address emerging crime trends. As a result, the program has led to numerous high-profile arrests and improved the department’s ability to identify and track offenders to assist in deploying resources more effectively.

In addition to enforcement, the GIVE initiative focuses on prevention and community involvement. The Jamestown Police Department’s primary community-focused program is the Citizen Police Academy. This program provides city residents with knowledge of police operations and helps foster stronger relationships between the department and the community.

STATEWIDE TARGETED REDUCTIONS IN INTIMATE PARTNER VIOLENCE:

In 2025, Governor Hochul launched the Statewide Targeted Reductions in Intimate Partner Violence (STRIVE) initiative. Drawing on the model established by the Division of Criminal Justice Services’ Gun Involved Violence Elimination (GIVE) program, STRIVE brings together the district attorney’s office, sheriff’s office, probation departments, and local service providers in a coordinated effort. The initiative focuses on developing a comprehensive, evidence-based response to intimate partner domestic violence, emphasizing accountability for offenders and the enhancement of safety and support resources for survivors.

Chautauqua County was awarded a total of \$847,225, with \$309,815 designated for our agency. A portion of this allocation has supported the hiring of a crime analyst who is responsible for identifying trends, assisting investigations, and enhancing our coordinated response. Additional funding will benefit operations through the improvement of resources and intimate-partner violence training.

Like GIVE, the STRIVE initiative is grounded in an evidence-based public-safety philosophy. Its six core elements include people, alignment, evidence-based strategies, engagement, skilled and supported staff, and monitoring and evaluation. While the two initiatives share a similar foundation, they differ in focus: STRIVE’s elements are designed to strengthen system responses to intimate-partner violence—prioritizing survivor safety, trauma awareness, and culturally responsive services—whereas GIVE centers on crime-control strategies that identify the high-risk individuals and locations driving gun violence.

ADMINISTRATIVE SUPPORT AND SERVICES DIVISION

The Administrative and Support Services Division is responsible for providing ancillary services to support department functions.

These services include management of department resources, management of the investigative section and non-sworn support staff. The Administrative and Support Services Division is divided into two sections: the Investigative Section and the Administrative Services and Support Section.

Investigative Section

Lieutenant Adam McKinley is the Investigative Section Commander, who is responsible for coordinating and leading criminal investigations within the unit. The Investigative Section has nine detectives and one Sergeant assigned to specialized units within the section. Although there are specialized units, the Investigative Section prides itself on working as a team to ensure that all crimes are fully investigated.

Detective Unit

- This unit has two detectives assigned. Their primary function is to conduct investigative follow-ups of major crimes and incidents after the patrol officers complete preliminary investigations.

Juvenile Unit

- The two detectives assigned to the Juvenile Unit investigate crimes involving victims and suspects who are 17 years of age or less, as well as felony assaults and sexual assaults where the victim is under 18 years of age. These detectives work closely with Child Protection, Social Services, Probation and Family Court.

Jamestown Metro Drug Task Force

- Three detectives are assigned to this unit. These investigators conduct drug investigations reported in the city. The detectives also assist the Investigative Section in investigations requiring surveillance and shared confidential informants. The actions of these investigators have a direct impact on the narcotics trade and crimes stemming from it.

Evidence and Property Management Unit

- Two detectives perform crime scene processing, which includes photography, evidence collection, finger printing and proper storage of forensic evidence. In addition, these detectives are evidence technicians, maintaining all collected evidence and ensuring it is properly forwarded to a lab for examination and or analysis, in addition to securing body camera evidence.

Domestic Violence Intervention Unit

- One patrol officer and one civilian employee, who is employed by Family Services, staff this unit. The unit is responsible for facilitating the Chautauqua County Coalition Against Domestic Violence and Sexual Assault by assisting and providing follow-up to victims of domestic violence.

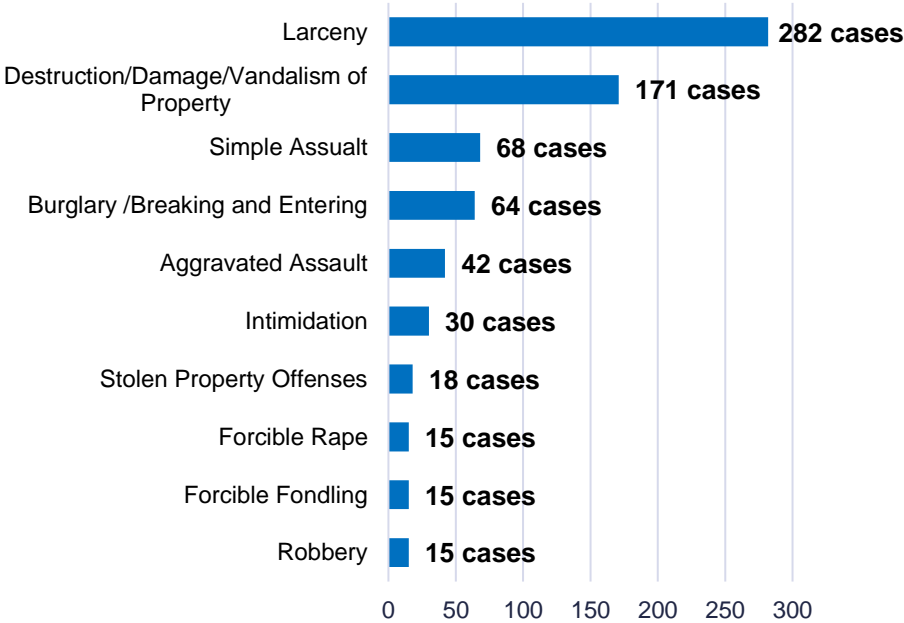

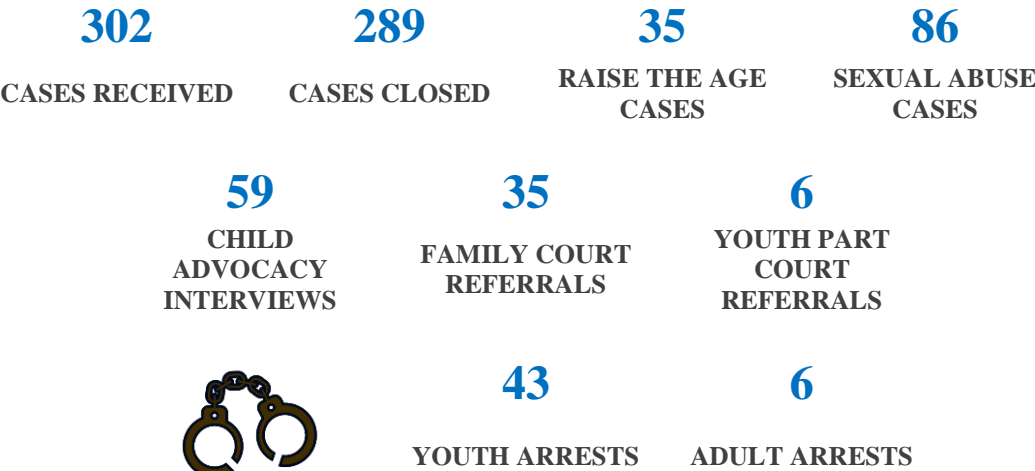
TOP TYPES OF CASES ASSIGNED TO DETECTIVE UNIT



Juvenile Unit

The Jamestown Police Department Juvenile Unit consists of two full-time specially trained detectives. Their specialized training includes the forensic interviewing of children, as well as suspect, victim and witness interviewing and statement taking. The detectives are responsible for the sensitive and lengthy investigations involving child sexual abuse, rape and crimes involving children under the age of 18. The juvenile unit handles crimes committed by both juvenile and adult suspects.

The juvenile unit uses a multidisciplinary team approach as an effective way to coordinate and conduct investigations. The team approach includes federal, state, and local law enforcement agencies, child protective services (CPS), The Child Advocacy Program (CAP), probation, family court, mental health agencies, regional health care providers, local school systems and other social service agencies. The team is a collaboration that strives towards an effective, prompt, and unified response to crimes committed against children.



2025 MAJOR CASES

E. 2nd St. Shooting / Assault - May 8, 2025

On May 8, 2025 the Jamestown Police Department responded to the area of E. 2nd St. at Hopkins Ave. for a victim with a gunshot wound. It was found that the victim had sustained a gunshot wound to the buttocks area. The victim was transported to the hospital for treatment. The Detective Bureau continued the investigation and secured numerous pieces of evidence. The investigation led Detectives to 20 year old Marquan Cunningham-Carper being named as the suspect. Cunningham-Carper was the subject of a narcotics investigation prior to the shooting and an arrest warrant was obtained for criminal possession of a controlled substance 3rd degree. Cunningham-Carper was arrested on the warrant on May 20th, 2025 and during the warrant service, Cunningham-Carper was found to be in possession of over 3.5 ounces of fentanyl. A subsequent search warrant was obtained for his residence and Detectives located a .38 caliber revolver and a high capacity .45 magazine with ammunition. Cunningham-Carper was charged with Assault 1st Degree, Criminal Possession of a Weapon 2nd Degree, Criminal Possession of a Weapon 3rd Degree, Criminal Possession of a Controlled Substance 2nd Degree, Criminal Possession of a Controlled Substance 3rd Degree, Criminal Possession of a Controlled Substance 7th Degree, and Criminally Using Drug Paraphernalia 2nd Degree as a result of these investigations.

E. 2nd St. Shooting/ Assault- July 24, 2025

On July 24, 2025 the Jamestown Police Department responded to the area of E. 2nd St. at Cheney St. for a victim with gunshot wounds. Upon arrival, it was found that the victim sustained a gunshot wound to the face as well as both legs. The victim was flown to UPMC Hamot hospital for treatment. The investigation continued and 23 year old Xavier M. Ramos was named as the suspect. Ramos was subsequently arrested the same day and charged with Assault in the First Degree and Criminal Possession of a Weapon Second.

Homicide of Michael Jaeckle- September 12, 2025

On September 12, 2025 the Jamestown Police Department responded to LaQuinta Hotel on W. 3rd St. for a male who had called 911 and was talking erratically. Upon arrival, officers located the male who was walking around with a machete and a crossbow. Officers were able to de-escalate the situation and speak with the male who was identified as 58 year old David W. Nelson. During conversation with Nelson, he eluded to there being someone in his apartment who had been shot by a crossbow. Officers responded to David's apartment on W. 4th St. where they located 62 year old Michael R. Jaeckle, deceased, from an apparent crossbow bolt that had been shot into his neck. Detectives along with Chautauqua County FIT members were called in to continue the investigation and process the scene. As a result, Nelson was indicted for Murder in the Second Degree and is being held in the Chautauqua County Jail pending a trial date.

JAMESTOWN METRO DRUG TASK FORCE (JMDTF)

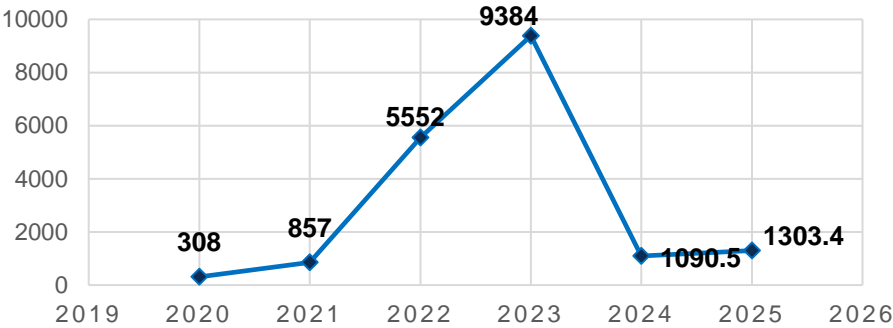
The Jamestown Metro Drug Task Force (JMDTF) took over as the primary unit to investigate drug investigations in the City of Jamestown in 2012. In 2014, the Ellicott Police Department joined in the effort to address narcotic issues in the greater Jamestown area. The JMDTF investigates narcotics cases assigned to them, conducts surveillance, and works with confidential informants. They also participate in the investigation of most major crimes in the City of Jamestown.

Jamestown PD K-9 Unit, Jamestown PD SWAT and other local, state, and federal partners, often assists the JMDTF. The JMDTF has recently been collaborating with the Chautauqua County Sheriff’s Office, in an effort to expand narcotics investigations affecting our community.

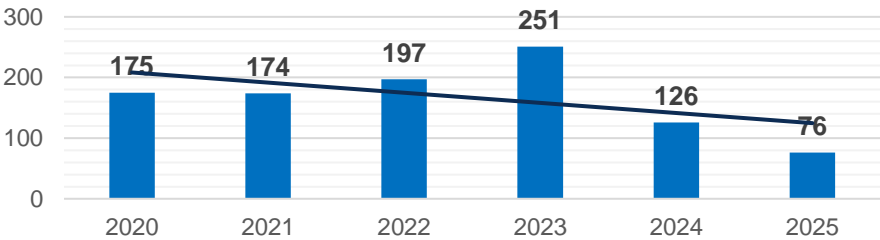
FENTANYL (GM) SEIZURES

January 8th, 2025

On January 8th, 2025 at about 3:47 PM members of the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed a search warrant at 567 Falconer Street Lower Rear Apartment. At the same time Jamestown Police Department road patrol executed a traffic stop on E. 2nd Street near Cowing Street where Rose E. Raynor was taken into custody. After the residence and Raynor were secured, detectives searched Raynor and located 157.4 grams of methamphetamine, 10.6 grams of fentanyl, and a small amount of cocaine on her person. There were also digital scales, packaging materials, and cutting agents located within the residence. Raynor was charged with Criminal Possession of a Controlled Substance 2nd Degree, two counts of Criminal Possession of a Controlled Substance 3rd Degree, two counts of Criminal Possession of a Controlled Substance 7th Degree and three counts of Criminally Using Drug Paraphernalia 2nd Degree. A male was located inside the residence and he was released from the scene.



January 21st, 2025

On January 21st, 2025 at about 11:33 am members of the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed a search warrant at 31 Fairfield Avenue Lower Apartment in Jamestown with assistance from the Jamestown Police Department K9 and Chautauqua County Sheriff's Office K9 after an investigation into the sale of methamphetamine in the City of Jamestown. Entry was made into the apartment where Samantha K. Robbins and a male were located inside and detained. A search of the apartment resulted in the seizure of 393.6 grams of methamphetamine, \$2,803.00 USC, packaging materials, a digital scale, and various other items. Robbins was taken into custody and transported to the Jamestown City Jail where she is being held pending federal charges.



January 14th, 2025

On January 14th, 2025, at about 11:18AM, Chautauqua County Sheriff's Narcotics Investigators, Jamestown Police Department Narcotics Detectives, Dunkirk Police Department Narcotics Detectives and Jamestown Police Department Officers, executed a search warrant at 49 West 11th Street in the City of Jamestown. Upon searching the residence, Investigators located 85.1 grams of cocaine, scales, packaging materials for the distribution of narcotics, a loaded .380 caliber handgun and stolen property. The resident of the apartment, Nylix J. Thomas was charged with criminal possession of a controlled substance 3rd degree (2 counts), criminal possession of a weapon 2nd, criminal possession of stolen property 5th and criminally using drug paraphernalia 2nd. Nylix J. Thomas is being held at the Chautauqua County Jail pending arraignment.



January 27th, 2025

On January 27th, 2025 at about 11:45 am, the Jamestown Police Department attempted to stop a vehicle leaving 2200 Camp Street Extension operated by 32-year-old Dylan M. Abbey. Dylan failed to comply and lead patrol on a pursuit on Manchester Road and back to 2200 Camp Street Extension where he proceeded to drive through the field but ultimately got stuck in the snow bank while attempting to exit the field onto Swanson Road. Dylan was taken into custody in the field without further incident. Immediately thereafter, members of the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed a search warrant at the residence located at 2200 Camp Street Extension with assistance from the Jamestown Police Department, Chautauqua County Sheriff's Office, Ellicott Police Department, and Dunkirk Police Department after complaints of drug sales. John J. Liscandro, Kenneth E. Wynn, Christopher W. Smith, and Jacklyn P. Webb were located and detained in the residence.



A search of the residence resulted in the seizure of 13 guns, 46.4 grams of methamphetamine, 2 grams of fentanyl, 236 suboxone strips, a quantity of pills, and \$655.00. A search of Dylan and his vehicle resulted in the seizure of 13.8 grams of methamphetamine, 12.7 grams of fentanyl, a quantity of pills, and \$2,490.00. Dylan faces charges in the City of Jamestown for Criminal Possession of a Controlled Substance in the Third Degree, Criminal Possession of a Controlled Substance in the Fourth Degree, Criminal Possession of a Controlled Substance in the Seventh Degree, two counts of Criminally Using Drug Paraphernalia in the Second Degree, and various Vehicle and Traffic Law violations. John, Kenneth, Christopher, and Jacklyn were transported to the Chautauqua County Jail and held for CAP Arraignment. John is charged with one count of Criminal Possession of a Weapon in the Third Degree, twelve counts of Criminal Possession of a Weapon in the Fourth Degree, Criminal Possession of a Controlled Substance in the Third Degree, Criminal Possession of a Controlled Substance in the Fourth Degree, Criminal Possession of a Controlled Substance in the Fifth Degree, Criminal Possession of a Controlled Substance in the Seventh Degree, and three counts

of Criminally Using Drug Paraphernalia in the Second Degree. Christopher, Jacklyn, and Kenneth are all charged with Criminal Possession of a Controlled Substance in the Third Degree, Criminal Possession of a Controlled Substance in the Fourth Degree, Criminal Possession of a Controlled Substance in the Fifth Degree, Criminal Possession of a Controlled Substance in the Seventh Degree, and three counts of Criminally Using Drug Paraphernalia in the Second Degree. Kenneth faces an additional count of Criminal Possession of a Controlled Substance in the Seventh Degree for a quantity of methamphetamine concealed on his person. The investigation is ongoing and further charges are expected. The Jamestown Police Department was assisted by the Chautauqua County Sheriff's Office, Dunkirk Police Department, and Ellicott Police Department.

March 13, 2025

On March 13, 2025, Narcotics Investigators from the Chautauqua County Sheriff's Office, City of Jamestown Police Department, and City of Dunkirk Police Department executed a search warrant at 11 Van Buren St. Apt. 3 in the City of Jamestown with Jamestown Police SWAT making entrance into the residence. Located inside the residence was Kevin Raymond. As a result of the search Investigators seized 350.6 grams of methamphetamine, 16.4 grams of fentanyl, scales and packaging used for the sale and distribution of narcotics, a stolen .22 cal. handgun and \$93.00 US Currency. Kevin Raymond was charged with Criminal Possession of a Controlled Substance 2nd, two counts of Criminal Possession of a Controlled Substance 3rd, Criminally Using Drug Paraphernalia 2nd and Criminal Possession of Stolen Property 4th. Kevin Raymond is being held pending an arraignment in the City of Jamestown Court.

April 3rd, 2025

On Thursday, April 3rd Narcotics Investigators in Chautauqua County assisted the DEA in an arrest for methamphetamine distribution in Celoron, NY. Investigators from Chautauqua County Sheriff's Office, Jamestown Police Department, Dunkirk Police Department and the DEA had been investigating methamphetamine drug trafficking from Akron, OH to the Jamestown area for the past three years. Information was received that a large quantity of methamphetamine was being transported to the Jamestown area on Thursday. Investigators were able to locate the vehicle and patrol officers from Jamestown Police Department and the Chautauqua County Sheriff's Office conducted a traffic stop on the vehicle at a residence in Celoron, NY. A search warrant for the vehicle was obtained by the DEA. A search of the vehicle resulted in the seizure of over 2 pounds of methamphetamine. Celina Serva from Akron, OH was charged with Possession with Intent to distribute 500 grams or more of methamphetamine. Serva will be arraigned in the US District Court for the Western District of New York in Buffalo, NY on Friday the 4th. Leslie Carnes was charged with Criminal Possession of a Controlled Substance 7th and was issued an appearance ticket to appear in the Town of Ellicott Court.



April 21st, 2025

On April 21st, 2025 at about 2:40 pm, members of the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed a search warrant at 26 W 9th Street Upper Apartment in Jamestown with assistance from the Jamestown Police Department SWAT Team after an investigation into complaints of narcotics sales. Upon making entry into the apartment, the SWAT Team located fourteen people inside. Luis Torres Cortes, Jimmy Alvarez Ocasio, Eric Carter, Jesus Lao Santana, Donald Swanson, Hector Dejesus, Shawn Beardsley, Terrence McRae, Jacob Trippy, Shane Davis, Heather Dean, Tammy Bair-Holman, Kaleb Dean, and Mackenzie Kelley inside. During the entry, detectives observed various items being thrown outside of a window. A search of the apartment resulted in the seizure of 4.1 grams of cocaine, 2.3 grams of crack cocaine, 28.8 grams of fentanyl, \$195.00, digital scales, packaging materials, and a handgun. Luis M. Torres Cortes is charged with Criminal Possession of a Weapon in the Second Degree, Criminal Possession of a Controlled Substance in the Third Degree (two counts), and Criminally Using Drug Paraphernalia in the First Degree (two counts). Jimmy Alvarez Ocasio is charged with Criminal Possession of a Firearm, Criminal Possession of a Controlled Substance in the Third Degree (two counts), and Criminally Using Drug Paraphernalia in the Second Degree (two counts). Eric Carter is charged with Criminal Possession of a Weapon in the Second Degree, Criminal Possession of a Controlled Substance in the Third Degree (two counts), and Criminally Using Drug Paraphernalia in the Second Degree (two counts). Jesus Lao Santana is charged with Criminal Possession of a Weapon in the Second Degree, Criminal Possession of a Controlled Substance in the Third Degree (two counts), and Criminally Using Drug Paraphernalia in the Second Degree (two counts). Donald Swanson is charged with Criminal Possession of a Weapon in the Second Degree, Criminal Possession of a Controlled Substance in the Third Degree (two counts), and Criminally Using Drug Paraphernalia in the Second Degree (two counts). Hector Dejesus was wanted by the Jamestown Police Department for a Petit Larceny and further found to be in possession of a quantity of fentanyl. He is additionally charged with Criminal Possession of a Controlled Substance in the Seventh Degree. Jacob Trippy was wanted by the Ellicott Police Department and turned over to them at the scene.

Beardsley, McRae, Davis, Dean, Bair-Holman, Dean, and Kelley were released from the scene. Due to the conditions of the apartment, the Department of Development responded and condemned the apartment.

May 20th, 2025

On May 20th, 2025 at about 1:40 pm members of the Jamestown Police Department conducted a street check of Marquan D. Cunningham-Carper in front of Pronto Mart located at 631 Newland Avenue. Marquan was taken into custody on an Arrest Warrant for Criminal Sale of a Controlled Substance in the Third Degree. Just prior to being detained, Marquan was observed discarding a baggie that contained approximately 4.25 ounces of fentanyl pills. A search warrant was obtained and the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed the search warrant at Marquan's residence located at 15 Columbia Avenue Lower Apartment in Jamestown with assistance from the Jamestown Police Department SWAT Team.



Entry was made into the apartment and nobody else was located inside. A search of the apartment and Marquan's person resulted in the additional seizure of a quantity of Lorazepam pills, digital scales, cutting agents, \$550.00 in United States Currency, cell phones, a .38 Special revolver, and a high capacity pistol magazine. In addition to the Arrest Warrant, Marquan is charged with Criminal Possession of a Controlled Substance in the Second Degree, Criminal Possession of a Controlled Substance in the Third Degree, Criminal Possession of a Controlled Substance in the Seventh Degree, two counts of Criminally Using Drug Paraphernalia, Criminal Possession of a Weapon in the Second Degree, and Criminal Possession of a Weapon in the Third Degree.

June 6th, 2025

On 6/6/25 at about 6:15 AM members of the Jamestown Metro Drug Task Force and Chautauque County Sheriff's Office Narcotics Investigators executed a search warrant at 508 W. 6th Street lower apartment with the assistance from the Jamestown Police Department SWAT Team. Jermeek D. Johnson and

Danielle R. Barber were located inside the residence where they were detained by the SWAT Team. After the residence was secured, detectives searched it and located 101.1 grams of fentanyl, 2.9 grams of methamphetamine, a quantity of Alprozalam pills, digital scales, \$1,633.00 US Currency and cutting agents consistent with the sale of illegal drugs. Johnson also attempted to secrete the methamphetamine and a quantity of the fentanyl in his person to avoid detection. Jermeek D. Johnson is charged with two counts of Criminal Possession of a Controlled Substance 3rd Degree, two counts of Criminal Possession of a Controlled Substance 7th Degree, two counts of Criminally Using Drug Paraphernalia 2nd Degree and Tampering with Physical Evidence. Johnson also had a Chautauque County Court warrant from possessing a large quantity of fentanyl and loaded hand gun from a search warrant executed at his residence in March of 2024. Barber had an outstanding bench warrant through Jamestown City Court. Both Johnson and Barber were transported to the Jamestown City Jail to await arraignment.



June 19th, 2025

In the early morning hours of Thursday June 19th, 2025, Narcotics Investigators from the Chautauque County Sheriff's Office, City of Jamestown Police Department, and City of Dunkirk Police Department executed a search warrant at 278 S. Main St. in the City of Jamestown with Jamestown Police SWAT making entrance into the residence. Located inside the residence was Thomas Kimbrough Sr., Samantha Perez and four juveniles. As a result of the search Investigators seized 34 grams of cocaine, 1.9 grams of fentanyl, scales and packaging used for the sale and distribution of narcotics and \$1,920.00 US Currency. Thomas Kimbrough Sr. and Samantha Perez were charged with two counts of Criminal Possession of a Controlled Substance 3rd, Criminally Using Drug Paraphernalia 2nd and Endangering the Welfare of a Child. Both subjects will be arraigned in the City of Jamestown Court.

July 23rd, 2025

A long-term narcotics investigation led to a large cocaine seizure in the Town of Gerry. On Wednesday July 23rd, 2025, Narcotics Investigators with the Chautauque County Sheriff's Office, Jamestown Police Department, and the Dunkirk Police Department executed a search warrant at 1842 Hanson Rd in the Town of Gerry with Chautauque County Sheriff's Office SWAT making entry into the residence. At the time of the entry, Chaze A. Johnson was located inside the residence. As a result of the search, Investigators seized 1.3 kilos of cocaine, 7.6 pounds of cannabis, 10.9 grams of MDMA, scales and packaging material for the sale and distribution of narcotics, three loaded semi-automatic pistols, two high-capacity pistol magazines, .22 caliber rifle, and \$11,278.00 US currency. Chaze Johnson was charged with Criminal Possession of a Controlled Substance 1st, Criminal Possession of a Controlled Substance 5th, Criminally Using Drug Paraphernalia 2nd, three counts of Criminal Possession of a Weapon 2nd and two counts of Criminal Possession of a Weapon 3rd. Johnson was transported to the Chautauque County Sheriff's Jail for the centralized arraignment program.

September 26th, 2025

On September 26, 2025, after a several month long investigation into narcotics activity in the City of Jamestown resulted in a search warrant being executed at 610 Monroe St. in Jamestown. Narcotics Investigators from the Chautauque County Sheriff's Office, City of Jamestown Police Department, and City of Dunkirk Police Department executed the search warrant at 8:35 am. Located at the residence was David E. Brown III. As a result of the search, Investigators seized 643 grams of cocaine, 40.4 grams of crack cocaine, scales and packaging used for the sale and distribution of narcotics and \$27,371.00 US Currency. David E. Brown III was charged with Criminal Possession of a Controlled Substance 1st and Criminally Using Drug Paraphernalia 2nd. Brown will be arraigned in the City of Jamestown Court.

October 17th, 2025

On October 17, 2025, Narcotics Investigators from the Chautauque County Sheriff's Office, City of Jamestown Police Department, and City of Dunkirk Police Department executed a search warrant at 130 Wilton Ave. in the City of Jamestown with Jamestown Police SWAT making entrance into the residence. Located inside the residence was Kevin R. Raymond, Dalton M. Nuse and Katherine I. Wood. As a result of the search Investigators seized 91.8 grams of methamphetamine, 19.0 grams of fentanyl, scales and packaging used for the sale and distribution of narcotics, a stolen .22 cal. handgun and \$2,048.00 US Currency. Kevin Raymond and Dalton M. Nuse were charged with Criminal Possession of a Controlled Substance 2nd, Criminal Possession of a Controlled Substance 3rd, Criminally Using Drug Paraphernalia 2nd, Criminal Possession of a Weapon 2nd and Criminal Possession of Stolen Property 4th. Katherine I. Wood was charged with Criminal Possession of a Controlled Substance 7th. Kevin Raymond and

Dalton Nuse were transported to Jamestown City Court for arraignment

October 22nd, 2025

An investigation into narcotics activity in the City of Jamestown resulted in a large seizure of methamphetamine. On October 22, 2025 at 12:25pm a search warrant was executed at 168 Barrett Ave. Apt. 1 in Jamestown by Narcotics Investigators from the Chautauqua County Sheriff's Office, City of Jamestown Police Department, and City of Dunkirk Police Department. Located at the residence was Cassandra M. Chadwick. As a result of the search, Investigators seized 7.7 pounds of methamphetamine, 5.5 grams of fentanyl, scales and packaging used for the sale and distribution of narcotics and \$1,198.00 US Currency. Cassandra Chadwick was charged with Criminal Possession of a Controlled Substance 2nd, Criminal Possession of a Controlled Substance 3rd and Criminally Using Drug Paraphernalia 2nd. Cassandra Chadwick will be arraigned in the City of Jamestown Court.

All three individuals are charged with Criminal Possession of a Controlled Substance in the First Degree, two counts of Criminal Possession of a Controlled Substance in the Second Degree, three counts of Criminal Possession of a Controlled Substance in the Third Degree, and two counts of Criminally Using Drug Paraphernalia in the Second Degree. All three individuals are convicted felons and were arraigned in front of the Honorable John Lamancuso Jr in the Jamestown City Court and committed to the Chautauqua County Jail without bail. The Jamestown Police Department was assisted by the Chautauqua County Sheriff's Office, Dunkirk Police Department, and Jamestown Fire Department.



November 13th, 2025

On November 13, 2025, at about 4:10 p.m. members of the Jamestown Metro Drug Task Force and Southern Tier Regional Drug Task Force executed a search warrant at 516 Palmer Street in the Upper Apartment after an investigation into the sale of various narcotics in the City of Jamestown. The Jamestown Police Department SWAT Team made entry into the apartment and located Jamal M. Jackson (who attempted to escape out of a second story window), Krystafur J. Bowman, and Jamarr A. Cunningham inside. A search of the apartment resulted in the seizure of approximately 136.1 grams of cocaine, 15.9 grams of crack cocaine, 291.5 grams of fentanyl, 485.3 grams of methamphetamine, a glass bowl for cooking the drugs, plastic baggies for packaging the drugs, digital scales for weighing the drugs, and a quantity of United States Currency believed to be proceeds from selling the drugs. All three were taken into

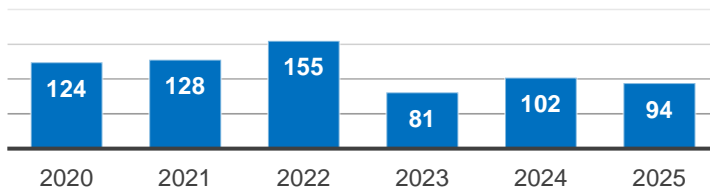

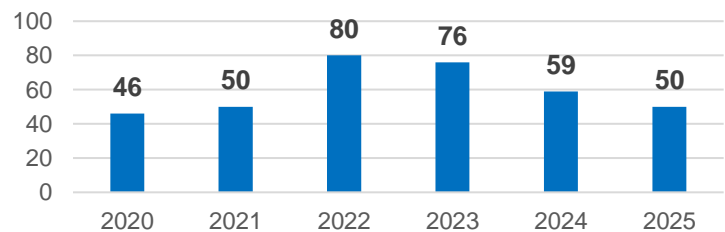
Gunshot Complaint Calls for Service

Firearms Seized as Evidence

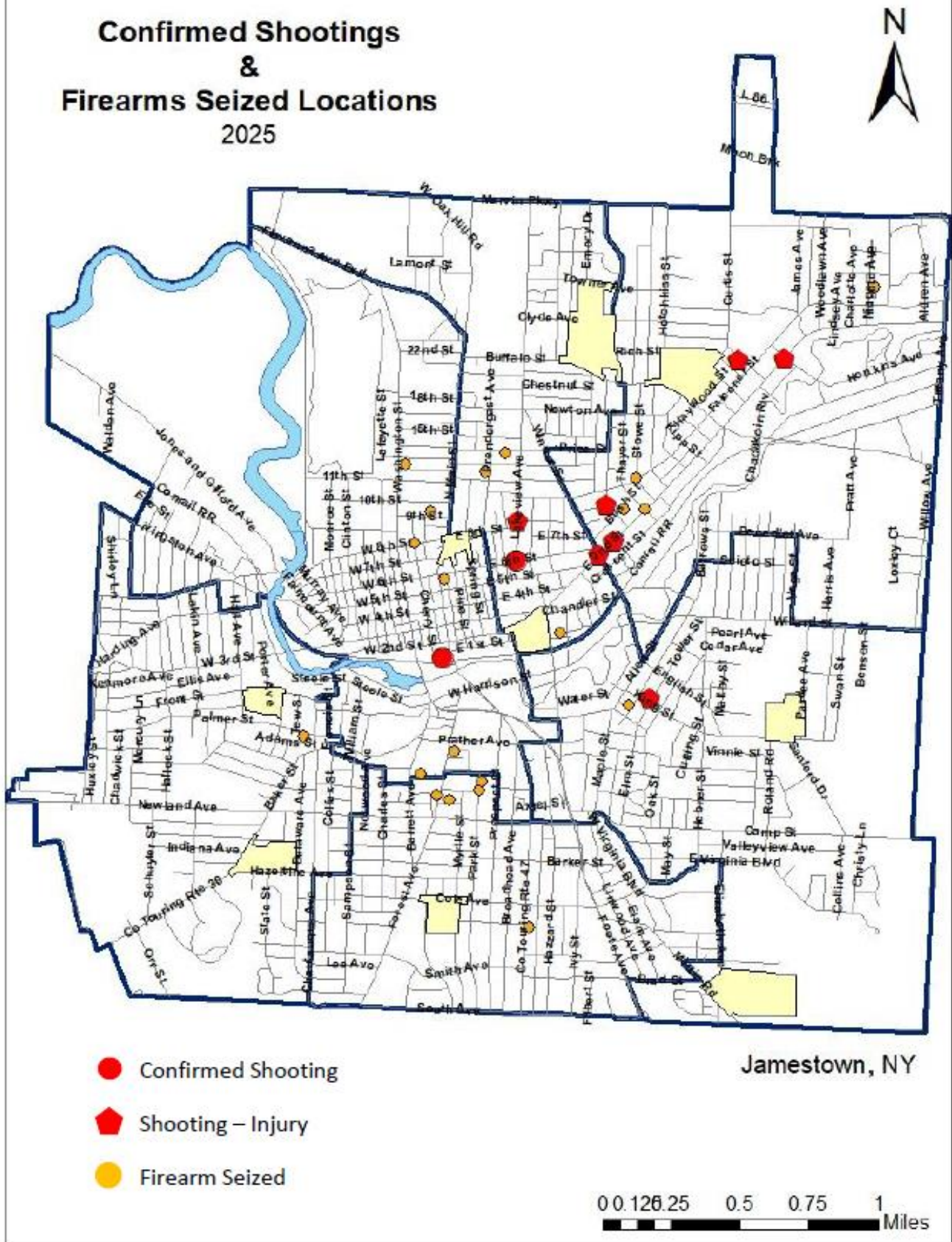


Weapons Law Violations per year



In 2025, weapons law offenses **decreased by -31.50%** compared to 2024 and **decreased by -5.84%** compared to the 5-yr average of **92.4 offenses**.

Confirmed Shootings & Firearms Seized Locations 2025



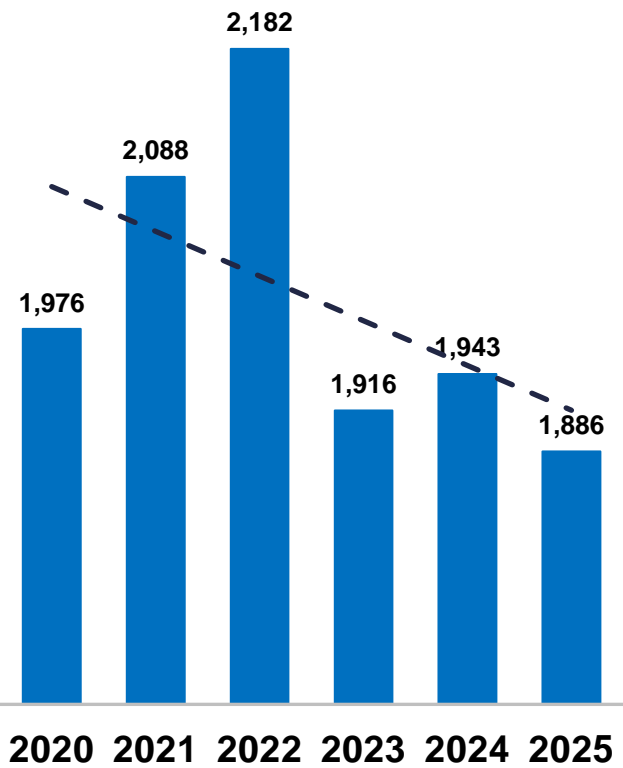

In 2025, the Domestic Violence Intervention Unit (DVIU) received 1,368 Domestic Violence Incident Reports that Jamestown Police Department officers took. Through Project Crossroads, the DVIU staff made over 1,000 follow-up contacts via phone calls and messages. Project Crossroads also completed 12 monthly strategic meetings focused on securing

The Domestic Violence Intervention Unit (DVIU) is responsible for facilitating the Chautauqua County Coalition Against Domestic Violence and Sexual Assault. This coalition implements a coordinated community response system to the epidemic of domestic violence while enhancing efficient delivery of services to victims. Through the coalition, staff have developed and implemented community awareness initiatives and events throughout Chautauqua County.

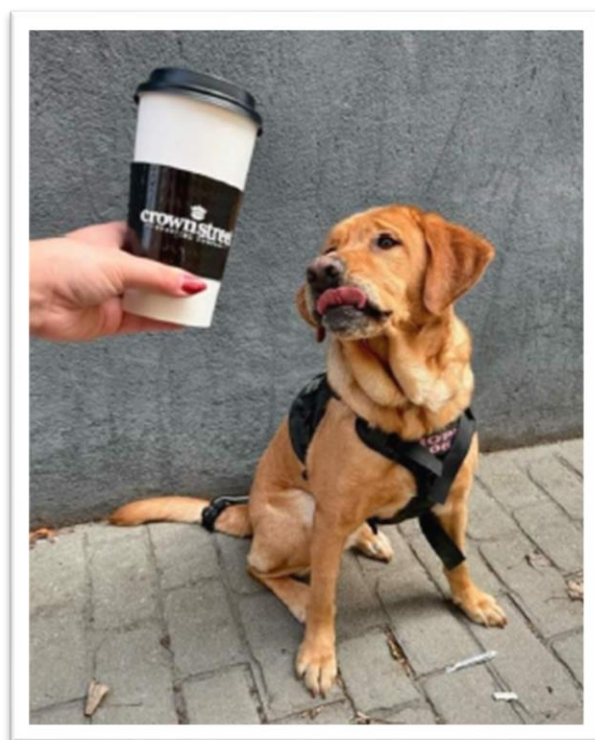
Domestic Incident Calls for Service

COMFORT K-9 HOPE

“Hope” started her career in January 2021 with Officer Emma Ward and facilitated 30 intakes to help de-escalate survivors and assist in obtaining trauma-informed statements in 2025.



Administrative Services Section

Records Management is staffed by four full-time civilian employees who are responsible for the repository of all department arrests record reports, case history reports, vehicle and traffic tickets and auto accident reports; the release of these records to the public; payroll, microfilm processing, mail and petty cash; liaison with UCR Reports, compensation, TSLED; budget duties; stenographic duties; and the maintenance of the Sex Offender Registry.

Information technology duties are performed by one full-time civilian employee who is responsible for performing certain computer programming services; entering, reviewing and monitoring the quality of information in the department's computer database; and coordinating officer automation services. This employee also provides technical assistance and instruction to department employees in the operation of computer and technical systems; acts as liaison with city and county data processing personnel; establishes, coordinates, and maintains schedules and inventories for the utilization of equipment in the department; and troubleshoots, analyzes problems and implements solutions to software and hardware problems. This person's duties also include coordination of software purchases and associated training; periodic analysis of department records management processing; assistance with data analysis; generation of internal and external reports relating to information technology systems and applications; as well as identification and evaluation of computer and technical systems problems.

This unit is also responsible for making periodic data backup files for the department; assisting programmers in technical aspects of interfacing computers to networks or mainframe computers; and researching and recommending new software and hardware applications for department activities.

Court/Building Security is staffed by four full-time and two part-time sworn court security officers who are responsible for protecting and guarding judges, non-judicial employees, jurors, parties, attorneys, witnesses, and the general public in the designated security screening equipment; collecting and securing property of persons entering court facilities; maintaining decorum in the court; and answering questions and directing the general public as necessary. These individuals are also accountable for guarding prisoners awaiting court action; maintaining order and assisting with judicial proceedings; and carrying out the directions of the court.

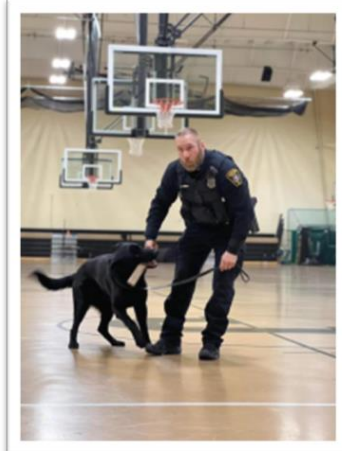
Jail Management is overseen by the Deputy Chief who is responsible for the administration of the city jail; compliance with regulations pertaining to the operation of the City Jail; completion of required reports to the NYS Commission of Corrections; coordination of operational functions with the administrative functions of the City Jail; selection and training of jail matrons; and maintenance of jail records.

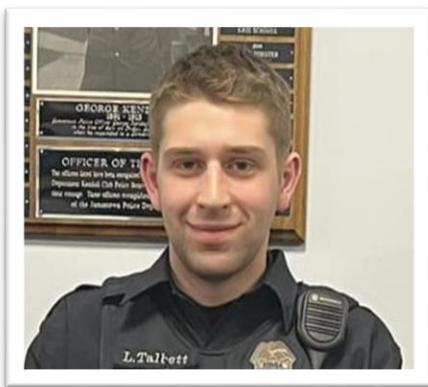

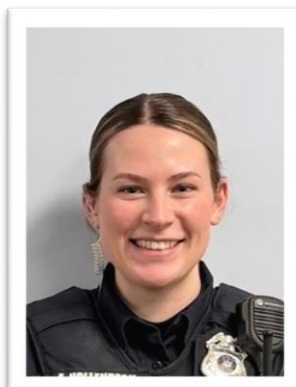

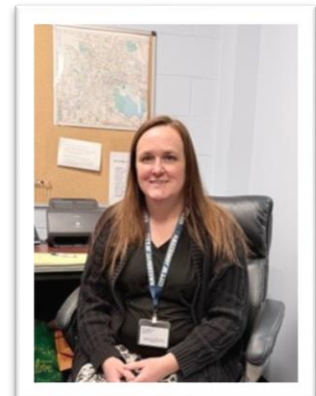
